Subject: Mandatory Registration of Archery Academies and Training Centres on RAA Portal

Sir / Madam,

The Rajasthan Archery Association (RAA) hereby notifies that it has been decided and approved by the competent authority of the Association that registration of all Archery Academies and Training Centres on the official RAA Portal shall be mandatory.

This directive is issued to ensure effective regulation, transparency, accountability, and uniform standards in the conduct and development of archery activities across the State.

Mandatory Instructions

1. All Archery Academies and Training Centres already affiliated with RAA shall compulsorily register themselves on the RAA Portal.
2. Academies and Training Centres not yet registered with RAA or with their respective District Archery Associations are hereby directed to regularise their affiliation and complete registration on the RAA Portal.
3. The RAA Portal will open for registration from 1st January 2026.
4. The last and final date for registration shall be 31st January 2026. No extension shall be granted under any circumstances.

Penalty / Disqualification Clause

It is hereby clearly declared that:

- Any Archery Academy or Training Centre failing to complete registration on the RAA Portal by 31st January 2026 shall stand automatically disqualified from participation in all District-level and State-level Archery Tournaments, Championships, Trials, Selection Events, Coaching Camps, and any other activities organised or recognised by RAA.
- Entries, nominations, results, and recommendations from unregistered academies or centres shall not be accepted, processed, or recognised.

- District Archery Associations shall strictly ensure that no entry from an unregistered academy or centre is forwarded. Any violation will attract administrative action, and responsibility shall lie with the concerned District Association.

Objectives of Mandatory Registration

The objectives of enforcing this mandatory registration are:


- To establish a verified and authentic database of all archery academies and training centres in Rajasthan.
- To ensure uniform coaching standards, safety norms, and infrastructure compliance.
- To maintain transparency and fairness in competitions, selections, and official events.
- To prevent participation of unauthorised and non-compliant entities.
- To strengthen coordination between RAA, District Associations, and affiliated academies for systematic growth of the sport.

All District Archery Associations are directed to circulate this circular immediately among all academies and centres under their jurisdiction and ensure strict and time-bound compliance.

Details regarding the registration procedure, documentation, and verification process shall be communicated separately.

This circular shall come into force with immediate effect and non-compliance shall be viewed seriously.
